- Ensure that we have the names, dates of birth, and social insurance numbers of all children under age 18.
- If one of your dependants was in full-time attendance at a university or college, please provide details concerning dependant's net income and tuition and education information (ie. Form T2202A). Please ensure form is signed by the student.
- Details of any capital gains and losses realized in 2022 including annual investment summary from broker.
- Inform us if you have sold any property, including your own residence, a rental or vacation property, during 2022.
- Details regarding RRSP Home Buyers' Plan or Lifelong Learning Plan withdrawals.
- If you purchased a home and did not own a home in the preceding four years, you may be eligible for the new first-time home buyer's credit. Please provide us with information to verify your home purchase.
